BACKGROUND

- Total Business Services and Training (TBST) is a small business services focussed RTO based in the Melbourne CBD at Docklands. It offers flexible online delivery supported by open face to face tutorial sessions.



- Its scope of registration is limited to business administration, bookkeeping and accounting qualifications at Certificate IV level. The latter qualifications in bookkeeping and accounting provide students with the base level educational qualification required under BAS Services Provider Legislation.
- Certificate IV students are trained in the use of the current version of MYOB as an integral part of their course and MYOB software is included in the course materials.
- The RTO is owned and directed by Ms Melissa Foote and she is supported by a total of 13 full time and contract administration and teaching staff.
- The RTO is an accredited training provider with the Institute of Certified Bookkeepers and has industry partnerships with the Australian Bookkeepers Network, MYOB and XERO.
- Target groups range from new entrants to financial services to experienced persons working in the industry. State government funding is available to eligible students. There are no corporate clients.
